EISF is a member-led network of NGO security focal points, committed to improving the security of humanitarian staff and operations for sustainable access

## Who we are

EISF began in 2006 as an initiative of global security focal points from several European NGOs, creating an informal alliance for information-sharing. The independent EISF network was formalised with the appointment of a part-time Coordinator in early 2008, based in Save the Children UK. EISF currently has over 80 members and the Secretariat has since grown to five staff members. EISF is currently hosted by Christian Aid in London.

The strategic direction of EISF is overseen on behalf of the members by a Steering Group, currently including Global Security Focal Points from Care International, Christian Aid, Danish Refugee Council, Goal, Medair, Médecins du Monde France, MSF Belgium, Oxfam GB, and Tearfund.

Membership of EISF is open to Europe-based not-for-profit NGOs which:

- Manage, and are responsible for, staff and significant humanitarian programme activities in several countries;
- Have a global security focal point who can represent them within EISF
