WHO WE ARE & WHAT WE DO

GISF is an NGO-led forum that drives positive change through our global network of over 145 humanitarian, development, and human rights member organisations operating internationally. GISF strives to strengthen the security risk management (SRM) capacity and effectiveness of organisations promoting the physical and psychological wellbeing of all staff through networking, coordination, collaboration, and information sharing. GISF builds and strengthens collective knowledge and skills and believes that breaking down silos and pooling expertise from a variety of sectors is crucial for improving humanitarian SRM. We are committed to achieving sustainable access to populations in need and keeping aid workers safe, through driving improved security risk management policy and practice.

GISF provides a balance of many types of products, services, opportunities for engagement, networking, sharing of good practice and learning, including:

- Production of original research reports, guides, articles, podcasts, and blogs;
- Delivery of workshops and events that aim to strengthen capacity and provide networking opportunities, bringing together GISF members with those of other networks, and experts from academia, the private sector and elsewhere;
- GISF website and library, providing on-line resources and services;
- GISF Chat, providing an opportunity for members to share information and direct support; and
- Participation in a wide range of thematic and sectoral events, meetings, networks
 and groups to ensure that security risk management is considered, silos are
 broken down, the needs of GISF members are met and their voice is heard in
 global debates.

GISF continues to provide an effective trusted network both within its membership and to the broader humanitarian community which enables the development and dissemination of good practice throughout the sector.

GISF AMERICAS

In 2022 our Americas office began to connect in-person with members again.

In July, our Executive Director, Lisa Reilly facilitated a workshop in New York in partnership with the UNDSS training team on Improving Inclusivity in Security Risk Management. More than 20 NGO and UN participants attended this one-day event.

GISF's Senior Project Officer, Tara Arthur, facilitated a three-day workshop in Panama City to support our growing community of NGO security professionals in the Latin America and



Caribbean region. With the support of trainers from Save the Children, International Rescue Committee and PSI, GISF delivered two workshops on Managing Sexual Violence, and Partnerships and Security Risk Management. The third day brought together LAC Regional Security Directors/Managers, and invited colleagues from the Middle East and North Africa Region (MENA) to share knowledge and experiences about their regional collaboration platform.

INFORMATION SHARED AND NETWORKS STRENGTHENED TO IMPROVE HUMANITARIAN SRM



FORUMS

The GISF forums are a primary mechanism that foster strong relationships and improve trust throughout the humanitarian SRM sector. They are well attended, and rated highly on quality and relevance, scoring an average of 3.35/4.

GISF held two hybrid forums in 2022:

March The Spring hybrid forum focused on Digital Security with three components: virtual, and in-person in Washington D.C., and Brussels.

Sept The Autumn hybrid forum focused on Collaboration, and was also held virtually, and in-person in Washington D.C., and Brussels.

Managing a global event across three time zones required a lot of planning but was managed successfully and received positive feedback from members. Offering an online element of forums has enabled wider participation, for example from regional







Security Focal Points, and brought a rich and fruitful level of experience and knowledge to discussions. Both forums maintained the essence of GISF's in-person events and included networking opportunities and a chance to feed into upcoming research, initiatives and priorities for 2023.

Membership

145 members | 89% of members engaged

GISF membership continues to expand, from 45 members 10 years ago to 145 by the end of 2022, with 96 full members and 49 associate members.

In 2022 alone, GISF accepted 12 new members (eight full and four associate), including four in North America. GISF continues to explore membership and networking opportunities to ensure that the organisation reflects a truly global perspective.





The comprehensive range of members and stakeholders that utilise GISF services, demonstrates GISF's unique position as the key trusted NGO security organisation with a wide range of global members, an expansive network, and extensive relationships with essential stakeholders. The close relationship maintained with members ensures our actions remain relevant.

Since going global in 2020, GISFs ability to meet objectives and better serve the needs of members and the wider humanitarian sector has gone from strength to strength. The North America office is pleased to be building momentum and engaging new members.

Our chat facility continues to thrive as an extremely useful resource for members to directly share information and questions as well as for the Secretariat to share updates and increase members' awareness of new tools and resources. Existing channels continue to engage members through discussions and sharing of policies and practice and provide an active and useful space for member coordination, including Digital Security, Ethiopia, and Afghanistan. Seven new channels were created in 2022: Ukraine (101 members), Burkina Faso (25 members), Pakistan (25 members), as well as new regional channels: West Africa Regional (35 members), LAC (31 members), MENA (32 members), East Africa (31 members).

PEER MONTHLY LEARNING AND EXCHANGE

As we continue with virtual working, these monthly sessions provide members with an opportunity for informal chats and discussions that previously took place in event and forum breaks. They have helped members connect on specific issues, and have kept the Secretariat in touch with members concerns and priorities.

Website and Library

GISF's online resource centre is an internationally recognised knowledge-sharing platform on SRM for the humanitarian sector. Consisting of an extensive library of documents, original resources, the GISF Blog and more, it also provides easy access to NGO-appropriate training providers, events, consultants, and improved recruiting of NGO security staff.

The member area of the website enables sensitive information and documents to be shared easily within the membership and not to the wider public. We continue to add relevant resources, vacancies, and new themes.



INCLUSIVE SECURITY

Toward Inclusive Security: the impact of 'race', ethnicity, and nationality on aid workers' security

GISF continues to be widely recognised for original research and translations, bringing new thinking into the sector as well as sharing good practice and lessons learned. In May, GISF published 'Toward Inclusive Security: the impact of 'race', ethnicity, and nationality on aid workers' security'. Presented during a session at Humanitarian Networks and Partnerships Week (HNPW), held by United Nations OCHA, the extended article received great feedback as well as prompting some impactful conversations that we will continue to build on in 2023.



RISK MANAGEMENT

Risk Management Under Uncertainty During the Afghanistan Crisis 2021

GISF supported the publication of a new report 'Risk Management Under Uncertainty During the Afghanistan Crisis 2021'. It examines lessons learnt from the international response to the Taliban takeover of Kabul in August 2021 and assesses how these can be used by SRM practitioners in today's complex operational environments.

NGO SECURITY TOOLBOX

+ two 'long read' resources

The GISF NGO Security Toolbox, published in April, was designed to provide accessible guidance, resources, and tools to help NGOs integrate good SRM practices into their operations in-country during humanitarian responses.



Two 'long reads' are incorporated: the 'NGO Security Collaboration Guide', which provides advice and practical resources to support effective security collaboration and the 'GISF Security and Safety

Training Pack' which provides ready-made resources and guidance to support the delivery of security training.

GISF and INSSA formally launched the Toolbox in June, during an engaging and well-attended webinar (155 attendees). The toolbox and the long-reads have provided country-level security staff and programme decision-makers with a range of easily accessible resources to enable comprehensive SRM, better security collaboration, and quality security learning programmes to be built into immediate humanitarian responses.

SECURITY RISK MANAGEMENT ESSENTIALS (SRME) CERTIFICATE

with Insecurity Insight and Disaster Ready

In July, GISF launched the Security Risk Management Essentials (SRME) Certificate with Insecurity Insight and Disaster Ready, a free online learning tool which provides humanitarian and development professionals with an introduction to vital security processes and policies.

We have started working on translating the certificate with Disaster Ready to ensure that the programme reaches a large number of humanitarian staff across the world.

GISF's reputation as the global coordination and resource hub, and centre of excellence for humanitarian security risk management continues to encourage high-level external engagement in strategic as well as practical discussions and events.

GISF promotes the voice of member organisations through regularly engaging in sector working groups and external events, ensuring that the NGO voice is both heard and listened to in debates which have implications for humanitarian security and access. Key regular groups include: H2H network, Security Institute - Inclusive Security Group, Saving Lives Together Working Group and Oversight Committee, WCAPS Orgs in solidarity, BOND groups on counter terrorism and sanctions, resilience and conflict sensitivity and gender.

Regular meetings have continued with major donors on security risk management issues including, FCDO, ECHO and OFDA.

2Workshops

November

GISF exhibited at AidEx, the largest international event for the humanitarian sector, in Brussels. We ran two workshops on 'Ensuring risk sharing and equitable SRM for all aid sectors: working with local partners and staff'. The first workshop looked at ways to build equitable SRM in partnerships between international and local partners. The second organised alongside Insecurity Insight, examined security incident sharing between international and local partners and assessed how this information can be used to protect health workers working through local partner organisations and national health structures.

For the second time, SRM was one of HNPW's 9 priority topics this year. Recognising GISF's leading role in supporting collaboration on SRM and improving aid workers' protection, GISF was selected to lead sessions on this critical topic.

Bringing together experts from across the aid world, GISF co-hosted nine in-person, hybrid, and virtual sessions focusing on Security in a Digital World and an Inclusive Approach to Security Risk Management in partnership with different actors such as the UN, ICRC, Dragonfly, WCAPS, Disaster Ready. Session topics included: Tackling misinformation and dis-information in humanitarian response; How does race and racism impact aid workers; Improving staff safety through effective donorship; Building an Organisational Culture for Effective SRM. Across the three weeks, 216 people participated in GISF sessions.

WORKSHOPS



In 2022, we organised two workshops in Spanish on Partnerships and Managing sexual violence, and one in French also on Partnerships. All received great feedback and allowed us to reach a wider global audience. GISF will continue hosting a range of non-English speaking workshops as and when resources and translations of GISF guides permits.

GISF delivered 10 highly rated capacity building workshops for members and other invited stakeholders. GISF's unique position enables the bringing together of expert facilitators and a wide variety of NGOs to share expertise and good practice, and to develop skills and encourage collaboration between individuals and agencies.


ROUNDTABLES AND WEBINARS

Webinars and roundtables have proved to be an effective and impactful way of engaging members in specific topics of interest, allowing participants to exchange information and discuss operational challenges during acute crises with other members, and invited experts.

As well as member only events, GISF conducted open access events, to enable outreach to non-members, and other interested parties. GISF developed and delivered 22 roundtables on contexts as they evolved and unfolded such as: Afghanistan, Ethiopia, Ukraine, West Africa, and Haiti.

25 webinars were held, in collaboration with external partners, on topics ranging from Supporting families of hostages – best practice from the family perspective; The challenges of humanitarian acceptance; Road Safety; and Professionalisation of SRM in the NGO sector. Dragonfly facilitated four webinars for GISF on topics including the strategic outlook for 2022, Ukraine, the Kenya Elections, and Rising authoritarianism in Central America.

In 2022, GISF produced a final module 'December 2022: COVID-19 – Where are we now?' in the guidance series 'Keeping up with Covid: essential Guidance for NGO security risk managers. The module gathers experiences and perspectives to assess the ongoing impact of COVID-19 on the world of humanitarian SRM to understand where we are now.



PODCASTS



The fourth GISF podcast series, Inclusive Security, continued, exploring the theme through the lens of security risk management.

It looked at elements of inclusive security, including aid workers personal

characteristics and unique risk profiles, what it looks like in the humanitarian context and how these factors can impact personal security. This series identifies the challenges that operationalising inclusivity can bring and asks 'What do security managers need to know, and how can they stay up to date and keep producing and designing inclusive security procedures?'





NEWSLETTER

GISF keeps members and other stakeholders up to date via our newsletters, focused on themes ranging from training opportunities, job vacancies, current research, blogs, opportunities for engagement. It spotlights specific issues and topics related to SRM. We have continued to receive positive feedback from members about the format launched in March, with Newsletters being listed as the primary platform for keeping up to date with GISF research and events.







GISF dedicates time to ensuring resources are made accessible to a wider audience through translation. French and Spanish translations of 'Partnerships and Security Risk Management: a joint action guide for local and international aid organizations (2021)', and an Arabic



translation of 'Security Risk Management: a guide for smaller NGOs' were made available. The translations have been well received by members.



University Engagement

We have continued to collaborate with the Humanitarian and Conflict Response Institute at Manchester University, and Lille University, with our Executive Director attending as a guest lecturer to advocate for the exploration of master's degrees in Humanitarianism and Humanitarian Security, and raise students' awareness of the topic.

GISF took its university programme forward, to increase awareness of the importance of SRM for enabling sustainable access to populations in need and SRM as a profession amongst the future humanitarians of tomorrow. A virtual webinar, led by a panel of experts, discussed career opportunities in SRM and covered essential topics relevant to aid delivery. It highlighted the importance of SRM, to introduce students and young professionals interested in the sector to the basics of SRM and why it's so important for safe humanitarian operations.

GISF move towards independence

In the UK, we are hosted by Mines Advisory Group (MAG) based in Manchester. ChildFund are the host of our team in the US. The Steering Group and secretariat met in December to discuss the new strategic direction for GISF for the next two years.

Following an in-depth look at our values and strategic objectives, it has been decided that GISF will continue its move towards independence when the current UK hosting arrangements

with MAG are due to end in October 2023. The decision to become an independent NGO signifies an opportunity to expand our donor base, focus on our mission, future proof GISF.

The Steering Group is leading the recruitment of a new Executive Director as Lisa Reilly, who has grown GISF globally over the last ten years, is leaving in March 2023.

The secretariat has expanded in 2022, creating and employing three additional positions:

MONITORING AND EVALUATION

We continue to monitor forums and events for quality and relevance to participants work; workshops are also evaluated for the impact and change-created in the participants approach to SRM. We incorporate event feedback from our members into subsequent activities. We collect such data through the member consultation and priority setting discussion at the Autumn Forum, member surveys, evaluations and feedback forms, and polls after events.

Salesforce, the Customer Relationship Management (CRM) database, allows the Secretariat to capture the level of engagement of members, and provides a central database to source information about our various stakeholders. We have used it as a project management tool to support research and other projects to enable a more streamlined event management process. In 2022 we have continued to work with an IT specialist and receive team trainings to integrate our systems (i.e., salesforce and zoom) and streamline our efficiency in tracking and monitoring members, events and engagement going forward.



05. FINANCE

GISF BUDGET

GISF's budget is reviewed by the Steering Group on a quarterly basis, and GISF's finances are independently audited as part of the Host organisation's annual audit.) Cost effectiveness is considered in all activities, and was kept under review throughout the. Any external contracts awarded, considered cost efficiency as one of the criteria and any significant changes in planned budgets were discussed and agreed. Wherever possible GISF utilises the resources of members and other network members to remain cost effective.
